1. CALL MEETING TO ORDER

2. APPROVE MEETING MINUTES

3. NEW BUSINESS

- ➤ Ed Terry is a Trustee involved with the Tracy property that is being divided and sold as building sites, tillable and rough land. Ed was inquiring about road easements and if any changes need to be made/approved. A motion was made by Emery to leave the easement as is on the Tracy Property in section 7; Larry seconded. - ➤ Planning Commission will be meeting in March to discuss potential changes/updates in the ordinances and report back at April meeting with recommendations. If any changes are proposed a public hearing would be scheduled to have conversations on what changes should be adopted.
- ➤ The Board approved format of March ballot used for the 2020 Township election.
- ➤ Resolution appointing election judges for the PNP (Presidential Nomination Primary) was signed and election judge schedule was set. The schedule will be: Darla, Cassandra, Emery, Mick and Jimmilee from 6am 1pm and Darla, Cassandra, Duwain, Diane and Larry from 1pm 8pm.
- Replacement of Automark-The County is considering replacing the Automarks with OmniBallot devices. The total estimated cost of each unit is \$4,425. The County has applied for state grant funds to help offset charges for Townships. The grants will range between \$500 and \$2,243 depending on number of applicants who apply. The final cost will be between \$2,002-\$3,745. The county

will be placing the order late July 2020 and bill Townships in late June 2021 with final payment due July 31, 2021. The County is considering additional storage and ownership options.

- ➤ Motion made by Emery to approve the 2021 budget set at \$250,000; Duwain seconded. All voted in favor; motion carried.
